

## Did You Move?

It is important that Bear Creek Community Charter School knows where each student physically resides. This information is required under Pennsylvania Law and we must share this information with your local school district of residence.

## Whenever a student's residence changes, parents/guardians must take the following steps:

- Notify Bear Creek Community Charter School by completing and returning a <u>Student Change of Address Notification Form</u> to the school office.
- Provide Bear Creek Community Charter School with <u>Proof of Residency (two)</u> for your new address. This can include a valid driver's license/photo ID card, utility statement, lease, deed, mortgage statement, property tax bill, homeowner's insurance card, voter registration card, etc.
- Submit a new <u>Transportation Form</u> to your local school district of residence, to coordinate transportation to and from school based on your new address. Forms and contact information are available on the School's web site at <u>www.bearcreekschool.com</u>
